

Terms & Conditions

Payments: A *non-refundable* deposit of \$100 (check or money orders only) payable to **Ticket to Travel Trust Account** is due at time of booking to reserve space. Additional deposits are due as follows: \$250 (credit cards accepted) is due prior to October 16, 2016. **Final Payment is due prior to December 1, 2017** (credit cards accepted).

Prices: Royal Caribbean International cruise fares are in US dollars. Prices and availability for staterooms outside of the Cafe Sewciety Quilts/Ticket to Travel group block of staterooms are subject to change. Optional land based pre or post cruise tour pricing will be in US dollars. Air fare is not included.

Cancellation Policy: **Café Sewciety Quilts/Ticket to Travel** reserves the right to cancel or re-schedule this cruise or any pre/post land tour in accordance with Royal Caribbean International operating requirements or circumstances beyond its control. Café Sewciety Quilts/Ticket to Travel is not liable for any cancellation penalties incurred on any other travel arrangements affected due to our cancellation, including air tickets purchased separately.

Cancellation Penalties: You must advise Cafe Sewciety Quilts/Ticket to Travel of cancellation in writing. Each *penalty* below is per person:

- If cancelled 89 to 57 days prior to sailing, \$250 (January 23, 2018 to February 24, 2018)
- If cancelled 56 to 29 days prior to sailing, 50% (February 25, 2018 to March 24, 2018)
- If cancelled 28 to 15 days prior to sailing, 75% (March 25, 2018 to April 7, 2018)
- If cancelled 14 to 0 days prior to sailing, 100% (April 8, 2018 to April 22, 2018))

Travel Insurance: Café Sewciety Quilts/Ticket to Travel strongly recommend that each passenger purchases travel insurance. Travel insurance is for covered reasons, primarily medical emergencies. Cancellations for any reason must be specified on policy. If passengers decline to purchase travel insurance, Café Sewciety Quilts/Ticket to Travel must be informed in writing. You may purchase travel insurance from your travel agent.

Medical and Disability Accessible: Any necessary medical attention needed during the tour will be provided by a local facility at the passenger's expense. Café Sewciety Quilts/Ticket to Travel is not responsible or liable for any losses or costs incurred as a result of medical services obtained while on tour, or for the quality of the care or services received. Travel outside of the US in most cases does not have the same standards and accessibility as the US.

Accommodations on this tour will differ from those in the US. Café Sewciety Quilts/Ticket to Travel cannot guarantee disability access. Prior to departure, passengers are required to advise Café Sewciety Quilts/Ticket to Travel of any physical, medical or other special needs that require accommodating. Passengers should be aware that this cruise trip and/or tours will include walking over cobblestone streets, uneven pavement, and steps which may not be easily accessible. All passengers must ensure they are medically and physically fit for travel and the cruise/tours offered.

For your comfort: There is a strict non-smoking policy on board motor coaches and all Royal Caribbean International staterooms. For any pre/post land tour, all hotels arranged by Café Sewciety Quilts/Ticket to Travel are non-smoking.

Meals: All meals are included in the 7-day Royal Caribbean International Cruise aboard the Allure of the Seas. Alcohol and specialty beverages are provided only by guest purchase. Café Sewciety Quilts/Ticket to Travel cannot guarantee special meal requests and cannot assume responsibility or liability if special meal requests cannot be met.

Transfers: Transfers can be arranged by your Café Sewciety Quilts/Ticket to Travel agent. Transfer costs are not included in the cruise pricing and will be an additional cost to the guest.

Accommodations: Royal Caribbean International Stateroom Accommodations: Prices for all staterooms are based upon two persons sharing a designated stateroom and include one private bathroom. Pricing and availability for single occupancy or more than 2 persons in a stateroom can be requested, but not guaranteed.

All roommate decisions must be made by guests and communicated to Café Sewciety Quilts/Ticket to Travel in writing. Guests seeking roommates may request that Café Sewciety Quilts/Ticket to Travel put them in contact with other guests who are also seeking roommates. By doing so, they are authorizing Café Sewciety Quilts/Ticket to Travel to share their telephone numbers and/or email addresses with those guests, if such information is available.

Café Sewciety Quilts/Ticket to Travel does not accept responsibility for roommate decisions/assignments; roommate “mismatches”; personality incompatibility; or any level of discord that may occur between roommates at any time or for any reason.

Surcharges: Guests are responsible for ascertaining if surcharges are required before dining in Specialty Restaurants, participating in ship’s activities, or utilizing its services. Café Sewciety Quilts/Ticket to Travel does not accept responsibility for any surcharges incurred by guests.

Porterage: Royal Caribbean International staterooms are designed to accommodate a maximum of two pieces of luggage per person. Café Sewciety Quilts/Ticket to Travel nor any of its agents or employees, shall be held liable for; and by accepting these documents customer waives any claim against all such parties for; (a) any loss of or damage to property or injury to any person caused by reason of any defect, negligence, or other wrongful act or omission of, or any failure of performance of any kind by; any other transportation company; vendor or supplier; (b) any inconvenience, loss of enjoyment, mental distress or other similar matter; (c) any delayed departure, missed connections, substitutions of accommodations, terminations of service, or change in fares or rates; and (d) any cancellation or double booking of reservations or tickets beyond the control of Café Sewciety Quilts/Ticket to Travel.
